# What does the Fund invest in?

The Fund invests in a mix of income-oriented mutual funds and equity mutual funds. The Fund follows the Manager's responsible approach to investing, which is described in the simplified prospectus of the Fund.

# How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### **Risk Rating**

NEI Investments has rated the volatility of this Fund as low to medium.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.


Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

# How has the Fund performed?

This section tells you how Series W units of the Fund have performed over the past 5 calendar years. Returns are after expenses have been deducted. These expenses reduce the Series' returns.

### Year-by-year returns

This chart shows how Series W units of the Fund have performed in each of the past 5 calendar years. Series W units have dropped in value in 1 of the 5 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



### Best and worst 3-month returns

This table shows the best and worst returns for Series W units of the Fund in a 3-month period over the past 5 calendar years and up to February 28, 2025. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

### Average return

If you had invested \$1,000 in Series W units of the Fund on its inception date, you would have \$1,307 on February 28, 2025. This works out to an annual compounded rate of return of 4.9% since inception.

<ul> <li>This Fund is an appropriate investment if:</li> <li>you are seeking a combination of current income and long term growth, through an investment diversified by asset class, style and geography</li> <li>you are looking for a fund that follows a responsible approach to investing, meaning it incorporates environmental, social and governance (ESG) factors into the decision-making process</li> <li>you are prepared for low to medium risk</li> <li>you are investing for the medium term</li> </ul>	In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

# How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series W units of the Fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. You should ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

Purchases of Series W units of Funds offered by NEI Investments are available under the front-end sales charge option only.

Front-end	0% to 5%	\$0 to \$50 on every \$1,000 purchased	This is a front-end sales charge option in which you pay a commission to your representative's firm when you buy the units. You negotiate the rate of commission directly with your representative's firm.	

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Series' returns. As of February 28, 2025, the Series' Fund expenses were 2.30% of its value. This equals \$23.00 for every \$1,000 invested.

Annual rate (as a % of the Fund's value)

#### Management expense ratio (MER)

This is the total of the Series' management fee (including the trailing commission) and operating expenses. In return for assuming the obligation to pay the Fund's operating expenses, NEI Investments is paid a fixed annual administrative fee.	2.13%
Trading expense ratio (TER) These are the Fund's trading costs.	0.17%

### More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your representative and his or her firm provide to you. NEI Investments pays the trailing commission to your representative's firm. It is paid from the Fund's management fee and is based on the value of your investment.

The trailing commission rate for the front-end sales charge option is 0% to 1.00% of the value of your investment each year. This equals \$0 to \$10.00 each year for every \$1,000 invested.

Effective June 1, 2022, payment of trailing commissions to order execution only (OEO) dealers are prohibited, which includes discount brokers and other dealers that do not make a suitability determination, in connection with an investor's purchase and ongoing ownership of Series W units of the Fund in an OEO account. As a result, Series W units are no longer available to investors who hold these units in an account with an OEO dealer. NEI Investments or your dealer may switch your Series W units into Series WF units of the same Fund if you hold Series W units in an account with an OEO dealer.

### 3. Other fees

You may have to pay other fees when you buy, hold, sell, switch or convert units of the Fund.

Fee	What you pay
Short-term trading fee	For transactions in excess of \$10,000, we may charge you 2% if a redemption occurs within 1 to 7 days, otherwise 1% within 8 to 29 days of purchase or switch payable directly to the Fund.
Switch or conversion fee	Up to 2% of the value of the securities you switch or convert may be charged to you and retained by your representative's firm as negotiated with your representative. However, you will not pay a conversion fee on NEI Investments-initiated conversions.
Insufficient funds fee	There will be a \$25 fee for non-sufficient funds cheques returned or if there are insufficient funds in your account to pay for your units.

# What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or fund facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, fund facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
