This form is used to set up the Northwest & Ethical Investments L.P. Electronic Funds Transfer (EFT) Service on your account. This will allow Northwest & Ethical Investments L.P., upon receiving redemption instructions from you, to directly deposit redemption proceeds from your Northwest & Ethical Investments L.P. account into your financial institution account.

## **Processing Instructions**

- 1. EFT is only available for Northwest & Ethical Investments L.P. accounts registered in investor's name.
- 2. This authorization form must be signed by the investor. The sales representative must verify the investor's signature to an original account signing authorization (usually account opening application).
- 3. Upon completion, fax the signed authorization form together with the void cheque, to 1-877-814-6115. Please retain the original form in investor's file.
- 4. Each account will require a separate EFT authorization form and void cheque.
- 5. The account registration of your NEI account must be exactly the same as the account registration of your bank account.
