# BEAR MARKET DECISION FOR THE BALANCED INVESTOR





### What this chart shows

If you invested 10,000 in a balanced portfolio at the start of 2007, by March 2009, the month global stocks hit bottom after the financial crisis, your investment was worth \$7,530 – a drop of nearly 25%. If you threw in the towel at that point and invested your remaining money in a 5-year GIC (not knowing of course that it was the bottom), 14 years later you would still be looking at a loss. If you had simply stayed invested, you would have more than doubled your money. If you had added 10,000, you would have earned roughly 3 times your total invested capital. ### The bottom line

It's impossible to know when the market is at a top or a bottom. But we do know that selling your investments after a steep loss can have a significant negative impact on your financial future. In other words: don't lose twice.
