

Semi-annual Management Report of Fund Performance

Management Discussion of Performance

Results of Operations

The NEI Fixed Income Pool's Series I units returned -4.8% for the six months ended March 31, 2022 compared with a return of -5.6% for the benchmark explained below.

Unlike the benchmark return, the Fund's returns are after the deduction of fees and expenses paid by the Fund. Performance differences between series of units are mainly attributable to management fees charged to each series. Refer to the Past Performance section for the details of returns by series.

The benchmark for this Fund is FTSE Canada Universe Bond Index.

The Fund's net asset value increased by 2.61% during the period, from \$392,705,221 as at September 30, 2021 to \$402,945,017 as at March 31, 2022. This change in net assets is attributed to net unitholder activity of \$30,606,888 and -\$20,367,092 to investment operations, including market appreciation (depreciation), income and expenses.

Factors That Have Affected Performance

The Fund maintained a short duration bias throughout most of the period in a rising rate environment. Combined with tactical adjustments and cash exposure, this resulted in a positive impact on performance.

The curve flattened throughout the period. Hence, the decision to favour long bonds relative to short- and medium-termed ones was beneficial for the Fund. The resulting excess cash was kept in the account or invested in short-term securities at the cost of additional carry for the Fund.

The underexposure to provincial credit was also accretive to relative performance as spreads widened. The bias was brought back to flat recently and benefited from the retracement into quarter-end. All of this was achieved in the longer portion of the curve since provincial holdings down the curve were kept underweighted. Furthermore, British Columbia, Alberta and Newfoundland were the largest holdings in this sector, and they outperformed their peers. The position in agency issuers was increased significantly in the second quarter as levels reached longer-term technical levels. They outperformed relative to provincial securities, which they replaced in the Fund.

The Fund remained overexposed to corporate credit while credit spreads initially compressed and then widened with the growing concerns surrounding the Ukrainian conflict and central bank hawkish rhetoric. No sector was spared from the recent widening, but the financial and real estate sectors suffered the most, as the Fund was overexposed to both. Adding to the telcom sector on new issuance in the long end and to short-term financials paid off as the issues came with large concessions during the last quarter.

Recent Developments

The slightly short duration positioning adopted at the beginning of the year has been covered and, with the market anticipating perfection in this cycle of increases, the portfolio sub-advisor prefers to stay close to index duration for the time being. The flattening of the interest rate curve was very profitable and was significantly reduced at the end of the quarter. Reducing that flattening bias allows for reallocation in the shorter portion of the curve.

Given the withdrawal of monetary accommodation by central banks and geopolitical risk, the portfolio sub-advisor does not feel a pressing need to increase exposure to provincial credit at this stage. In fact, although spreads are still wider than in all of 2021, they are only sitting on the long-term average, and are expected to widen from current levels. Thus, any further rallies will be sold.

Following the recent widening of credit spreads, the portfolio sub-advisor believes that their risk/return now warrants an overweight position, mainly in the short-term sector. Preferred sectors include banks (bail-in debt), utilities (long end versus provincial bonds), energy generation, pipelines (except in the long end), REITs and telecommunications. A more neutral view will be kept in the oil and gas sector through Cenovus and North West Redwater. Underweighted sectors include ABS, insurers, financial services and retailers. Issuer selection is always important, but more so during periods of geopolitical and economic turbulence, and ESG scores remain a factor in selecting specific issuers. Green and sustainable bond issuance will be analyzed with care and integrated into the Fund when conditions are met. For the long-end portion of the curve, the portfolio sub-advisor will increase exposure as spreads widen. Mid-termed exposures will be reduced to balance the Fund.

Related Party Transactions

Northwest & Ethical Investments L.P. ("NEI LP") is the Manager, Trustee, Portfolio Manager and Registrar of the Fund. Northwest & Ethical Investments Inc., the general partner of NEI LP, is a wholly-owned subsidiary of Aviso Wealth Inc. ("Aviso"). Aviso is also the sole limited partner of NEI LP. Aviso is a wholly-owned subsidiary of Aviso Wealth LP, which in turn is owned 50% by Desjardins Financial Holding Inc. and 50% by a limited partnership owned by the five Provincial Credit Union Centrals and The CUMIS Group Limited. Desjardins Financial Holding Inc. is a wholly-owned subsidiary of the Fédération des caisses Desjardins du Québec ("Fédération").

NEI LP charges the Fund a fixed administration fee in place of certain variable expenses. NEI LP in turn, pays all operating expenses of the Fund, other than specified fund costs (e.g. the fees and expense of the Independent Review Committee ("IRC"), taxes, and brokerage commissions) which include payments to related parties. These services are in the normal course of operations and are measured at an exchange amount that is consistent with other independent parties. Desjardins Trust Inc. ("Desjardins Trust") is the custodian of the Fund. Desjardins Trust is a wholly-owned subsidiary of the Fédération. The Fund may engage in securities lending and repurchase transactions, and Desjardins Trust may act as the Fund's securities lending and repurchase transactions agent ("Agent"). Any revenue earned on such transactions is split 60%—40% between the Fund and the Agent. Desjardins Securities Inc. ("DSI") is a broker responsible for security transactions on behalf of the Fund. DSI is wholly-owned subsidiary of the Fédération. Desjardins Global Asset Management Inc. ("DGAM") is the Portfolio sub-advisor of the Fund. DGAM is a wholly-owned subsidiary of the Fédération. DGAM's fees are entirely paid by NEI LP.

The Fund's sub-advisors may place a portion of their fund transactions with brokerage firms which are affiliates of NEI LP, provided that the affiliate's trade execution abilities and costs are comparable to those of non-affiliated qualified brokerage firms.

The Fund is currently only distributed by NEI on an exempt-market basis.

NEI LP has established the IRC for the Fund in accordance with the requirements of National Instrument 81-107 – Independent Review Committee for Investment Funds in order to review conflicts of interest as they relate to investment fund management. The Fund did not rely on an approval, positive recommendation or standing instruction from the Fund's IRC with respect to any related party transactions.

These amounts are reviewed at each calendar year-end and management engages in discussions with the sub-advisor to determine the most applicable strategy on a go forward basis and will take any action(s) as needed for the long term stability of the Fund.

(1) Management expense ratio is based on total expenses (excluding commissions and other portfolio transaction costs, as well as withholding taxes) for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

(2) The trading expense ratio represents total commissions and other Fund transaction costs expressed as an annualized percentage of daily average net asset value during the period.

(3) The portfolio turnover rate indicates how actively the Fund's sub-advisor manages its investment holdings. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher the portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.

Management Fees

The Manager is responsible for the management, supervision and administration of the Fund. The Fund does not pay management fees for Series I units. Series I unitholders pay a negotiated fee directly to NEI Investments.

In addition to the fees and expenses directly payable by the Fund, certain fees and expenses may be payable by some underlying third party funds. The Fund indirectly bears its proportionate share of such fees and expenses. However, the Fund does not pay any management fees or similar expenses that, in the view of the Manager, a reasonable person would consider duplicate a fee payable by an underlying fund for the same service.

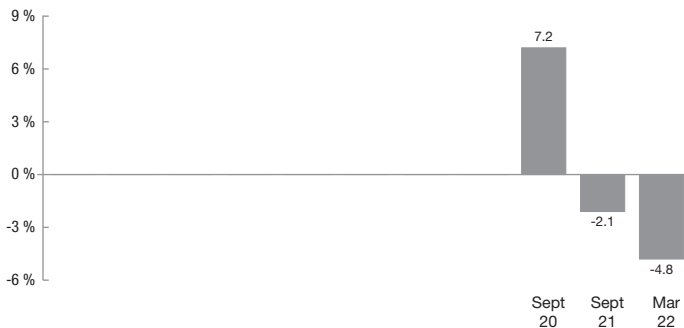
Past Performance
